I, the undersigned, do hereby acknowledge, covenant, and agree for myself, my family, heirs, and assigns as follows:

1. Participation in the Adventure activity including travelling in vehicles, trekking, hiking, climbing, camping can result in injury or accidents. Exposure to the natural elements like Sunburn, dehydration, heat exhaustion, heat stroke, heat cramps, wind, rain, Cold, Altitude sickness, difficult terrain, Fatigue and Exhaustion can be uncomfortable or harmful or cause injury.
2. I understand that there is a certain level of unpredictability and uncertainty and discomfort associated with the any adventure activity. Things may not go as planned. There may be delays in starting the journey or delays reaching the intended destination. Food can be cooked outdoors and may not be delicious. Stay may be outdoors and not comfortable or luxurious.
3. I acknowledge and I am fully aware of the inherent risks associated with participation in the Trip/Activity and to the maximum extent allowed by law, I Waive, Release, and Discharge The Great Hyderabad Adventure Club, Its Organizers, Members & Associates from any negligence, claims, losses, or causes of action including, but not limited to death, personal injury or property damage arising out of my own voluntary participation in the above mentioned activity/trip.
4. I understand that the said activity I am participating is an amateur outdoor activity organized by the club which is meant for recreation purpose only. I understand and agree that the Organizers have simply facilitated the gathering of members interested in the Trip/Activity and I am voluntarily participating and consented to my own risk and peril involved in this Trip/Activity.
5. I affirm that I am in good physical health and have read the difficulty rating and I am confident of my ability to take part in the said activity. I have no significant Injury, medical ailments or conditions that would counter-indicate any disability to take part in the outdoor activity.
6. Rules and regulations have been adopted for the safe enjoyment of the activity and I agree to adhere to those regulations and all other club rules as displayed on the website www.ghac.in.
7. I will follow the organizers instructions and I will not deviate from the planned route. I will not Litter, Smoke or Drink Alcohol. I will pay all shared expenses and dues and any other additional expense that may come up later.
8. I hereby give permission for the Great Hyderabad Adventure Club and its Organizers to secure medical treatment for me in the event of an emergency. I authorize the physician or medical personnel or Certified First Aider present to provide treatment deemed necessary by them.

I confirm that I am 18 years of age or older and under no legal constraint or impediments and I acknowledge that by signing this agreement, I or the minor/ward on whose behalf I sign for will be bound to its terms.
